FAN affirms our commitment to the Darlington Statement, developed by intersex organisations and advocates in 2017, which articulates the human rights demands of people with intersex variations in Australia and Aotearoa/New Zealand.

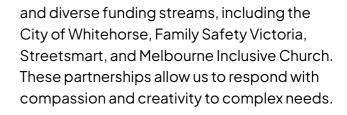
Key Milestones

This year brought many proud moments:

- Secured four more years of **Pride in Place** funding.
- Continued delivery of Pathways to Resilience for LGBTIQA+ young people.
- Delivered critical rental, education, and employment support through Creating Connections.
- We also remained an active voice in sector reform through networks such as the EHSSA, the Pregnancy and Homelessness Coalition, and the Regional Family Violence Partnership.
- I was personally honoured to join the Ministerial Homelessness Reform Action Group (MHRAG), contributing directly to reforms aimed at ending homelessness in Victoria.

Strength Through Partnerships

Our core homelessness services, funded by the Department of Families, Fairness and Housing, were strengthened by valued partnerships



Creativity and Advocacy

Our first **Creative Art Therapy** program continued, **Talking with Pride** was delivered, and community education expanded. We met rising food insecurity with increased material aid, while farewelling the **Eastern Diversity Group** and **Young Mums Group** with gratitude for their lasting impact.

These achievements are only possible thanks to the dedication to our Board, staff, students, and volunteers, whose dedication brings FAN's values to life.

At this year's AGM, we will launch the **Sue Carlile Community Spirit Award**, honouring a young person's outstanding contribution to their community. Together, we look toward a future where youth homelessness is history.

Client Services Report

In 2024–2025, our Client Services Team stood shoulder to shoulder with young people facing homelessness or the looming risk of it.

We didn't just provide services; we walked alongside them, listened to their stories, and worked together towards brighter futures.

Key impact

- 687 total supports delivered including 59 children.
- 66 young people and 10 children received a safe place to call home through our transitional housing properties and outreach program.
- 407 group supports provided through Young Mums' Group, Eastern Diversity Group, and Talking with Pride.

Our holistic approach

Every young person was supported in a way that put them first, helping them pursue education, find work, care for their health, secure housing, and build social connections.

Specialised, inclusive care

We know that not all homelessness looks the same. Young families and LGBTIQA+ youth often face deeper, more complex challenges. That's why they received dedicated properties and tailored, one-on-one support from our youth workers.

For those who had experienced family violence, we offered counselling and creative arts therapy through *Pathways* to *Resilience* and our *Creative Arts Therapeutic Program*.

For LGBTIQA+ youth experiencing homelessness, *Pride in Place* provided tailored service navigation and housing support.

Every number here represents a real life changed. Together, we turned hardship into possibility.

Treasurer Report

On behalf of Family Access Network, it is my pleasure to present to you the Treasurer's report for the year ended June 30, 2025.

We would like to take this opportunity to recognise the ongoing funding from Department of Families Fairness and Housing (DFFH), for our core Homeless Support Services including transitional support, Private Rental Brokerage Program and Housing Establishment Fund. In addition thank you to Homes Victoria (part of DFFH) for their funding of our Pride in Place program and thank you to Family Safety Victoria for their funding of the Pathways to Resilience Family Violence Therapeutic Intervention. Also thank you to the Paul Ramsay Foundation for the funding of the Therapeutic Arts Practitioner program over the last 2 years. I would also like to acknowledge the support from Whitehorse City Council over many decades in grants through the Partnership Funding that supported the delivery of our Life Skills and Volunteer Programs.

In addition, we are grateful to other members of the community, Philanthropic Trusts and supporters who have contributed to Family Access Network through financial and in kind support, which ultimately supports additional programs and related equity supports for clients who access our services.

Our asset to liability cover of 2.6 is more than sufficient to meet our operational requirements. Our net assets are \$767,877



Surplus/Deficit

For the 24/25 financial year FAN generated an operating surplus of \$12,218 against a budgeted surplus of \$5,700. Total income for the year was \$1,345,140. Total expenses for the year were \$1,332,922. A breakdown of these expense lines can be found in the annual report.

In 2024–2025 financial year, FAN supported **628 young people**, including **59 children** in the following ways:



39 young people and their 10 accompanying children were supported in transitional housing



66 young people and their 2 accompanying children

Program Highlights

Wear it Purple Day 2024 Clothing Swap

In August, FAN celebrated Wear it Purple Day by hosting a Clothing Swap at Box Hill Mall. The event went beyond exchanging clothes — it created a safe, welcoming space where LGBTIQA+ young people and allies could feel affirmed and supported.

The Clothing Swap successfully:

- Brought together 63 participants from the LGBTIQA+ community and their allies.
- Provided clothing that helped affirm participants' identities.
- Celebrated and supported LGBTIQA+ young people.

The event encouraged meaningful conversations about the unique challenges faced by LGBTIQA+ youth and fostered a strong sense of connection and community. Feedback highlighted the inclusive and affirming nature of the event, with participants appreciating both the welcoming environment and the tangible support offered.

FAN extends special thanks to the Youth Connexions team at Whitehorse City Council for their partnership in making this event possible.

Homelessness Week 2024

FAN participated in the 2024 National Homelessness Week (5–11 August), which focused on the theme *Homelessness Action Now*. The week highlighted the urgent need for long-term solutions to homelessness, including coordinated approaches, social housing, and community awareness. On any given night in Australia, over 123,000 people are experiencing homelessness.

As part of the campaign, FAN contributed to a display at Parliament House featuring more than 6,000 origami houses, symbolising the scale of the housing crisis and the need for urgent action. The display aimed to raise public awareness about the importance of adequate incomes, access to affordable housing, and



safety from violence as essential steps toward ending homelessness.

Through initiatives like this, FAN continues to advocate for systemic change while educating communities on how they can contribute to lasting solutions.

Program Highlights

Talking with Pride Art Exhibition

In January 2025, FAN proudly supported Talking with Pride participants to create and curate their first art exhibition. Nine talented young people showcased over 40 works as part of the annual Midsumma Festival.

The exhibition was officially opened by Iain Finlayson, Cultural Services Coordinator for the City of Whitehorse, with FAN's CEO Michelle Thompson commending the artists and welcoming guests. FAN was also honoured to host Joe Ball, Victorian Commissioner for LGBTIQA+ Communities, whose team expressed great admiration for the young artists' work.

For many participants, this was their first time exhibiting publicly—an experience they described as exciting and inspiring, with hopes for future exhibitions. The monthlong display drew many visitors, generated glowing feedback, and saw multiple artworks purchased.

FAN congratulates all the artists and thanks Timothy from Box Hill Community Arts Centre and Jess from FAN for their dedication in bringing this event to life. We look forward to supporting more opportunities for young people to share their creativity.

IDAHOBIT 2025 Box Hill Community Event

On 15 May, FAN was proud to partner with Whitehorse City Council for the annual IDAHOBIT event at Box Hill Mall. The event was a wonderful and vibrant celebration of inclusion and support for the LGBTIQA+ community.

The event brought together a wide range of local organisations including EACH, Burke and Beyond, Whitehorse and Manningham Libraries, Gateway LLEN, Eastern Community Legal Centre, Box Hill Institute, Community Housing Limited, and Headspace Box Hill. Together, we created a welcoming space filled with live entertainment, activities, face painting, and free treats for young people and families.

Case Study:

Jordan's Journey to Independence

When Jordan arrived in Victoria in early 2024, they were seeking a fresh start after leaving an unsafe family environment in another state. With few local connections and a strong desire for stability, Jordan was referred to Family Access Network (FAN) for support.

The transition wasn't easy. Jordan spent time in crisis accommodation while adjusting to a new community, managing anxiety, and learning the skills needed to live independently. With consistent support from FAN workers, they began to build confidence and establish a sense of routine.

Moving into transitional housing marked a turning point. Jordan participated in a retail training program, where they received excellent feedback for their enthusiasm and reliability. They also developed a better understanding of the supports available to help them feel safe, connected and capable.

Recently, Jordan secured a private rental, a huge milestone in their journey. FAN provided assistance through the Private Rental Brokerage Program (PRBP) and Housing Establishment Fund (HEF), helping cover rent and moving costs. They also accessed employment and education funding (CEEP) to strengthen their work-readiness skills.

With the help of a Youth Outreach Recovery Service (YORS) at EACH and now a local YORS service, Jordan continues to prioritise their mental health and community connections.

Now settled in their new home, surrounded by supportive friends and a caring partner, Jordan is looking forward to future work in retail and continuing to build the independent life they've worked so hard to achieve.

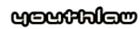

Recognition and Awards

Stephen B McLoghlin Encouragement Award

Stephen McLoghlin was the Youth Development Worker at the former Box Hill City Council (a predecessor of the City of Whitehorse) in the 1970's and 80's; and the founder of FAN. He was instrumental in the development of many youth projects and was one of the earliest instigators of leadership programs for young people. FAN as we know it officially commenced in April 1981, however, the foundation work by Stephen McLoghlin preceded that by several years. As a person known for his ability to inspire, it was appropriate that an annual Stephen B McLoghlin Encouragement Award be introduced at the FAN AGM in 2010, as a tribute to his vision and a permanent memorial to his legacy.

The Stephen B McLoghlin Encouragement Award recipients for 2025 is Stacey

Rhys Fox Achievement Award

During the late 1970s and early 1980s Rhys Fox, through his voluntary involvement contributed to the emerging youth homelessness services in the Eastern Metropolitan Region. In his will he begueathed a sum of money to FAN which has been placed in Trust. The interest earned each year is allocated to the Rhys Fox Achievement Award. The presentation at each year's Annual General Meeting recognises his legacy to the community in a way that both honours his commitment and acknowledges the exceptional achievements of young people. FAN is proud that this tradition dates from 1994.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30TH JUNE 2025

The financial statements cover FAMILY ACCESS NETWORK INC as an individual entity. It is a not-for-profit association incorporated in Victoria under the Associations Incorporation Reform Act 2012 and it is registered with the Australian Charities and Not-for-profits Commission Act 2012. It is a charitable institution and as such it is exempt from income tax.

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Preparation

The financial statements are special purpose financial statements that have been prepared to satisfy the financial reporting requirements of Australian Accounting Standards and the Associations Incorporation Reform Act 2012 and the Australian Charities and Not-for-profits Commission Act 2012. The Committee has determined that the association is not a reporting entity.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in financial statements containing relevant and reliable information about transactions, events and conditions. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless otherwise stated. The association adopted AASB 1058 and AASB16 effective from the 1st July 2019.

Reporting basis and conventions

The financial statements have been prepared on an accruals basis and are based on historical costs modified where applicable by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

Accounting Policies

Revenue and Other Income

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

The Association has adopted AASB 15 Revenue from Contracts with Customers from the 1st July 2018 whereby the entity recognizes revenue when the amount of revenue can be reliably measured, and it is probable that the future economic benefits will flow to the entity and specific criteria have been met for each of Family Access Network Incorporated's activities as discussed below.

Revenue is recognized based on the contractual specific period the revenue is applicable to.

For revenue from Grants where the Grant details specific performance requirements and time lines; Revenue is recognized based on these specific performance timelines.

All revenue is stated net of the amount of Goods and Services Tax (GST)

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30TH JUNE 2025

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the balance sheet are shown inclusive of GST.

Cash flows are presented in the cash flow statement on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

Critical Accounting Estimates and Judgments

The Board evaluate estimates and judgments incorporated into the financial report based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the group.

Key estimates - Impairment

The entity assesses impairment at each reporting date by evaluating conditions specific to the entity that may lead to impairment of assets. Where an impairment trigger exists, the recoverable amount of the asset is determined. Value-in-use calculations performed in assessing recoverable amounts incorporate a number a key estimates.

No impairment has been recognised in respect of this financial year.

Income Taxation

The association is a charitable institution as such it is exempt from income tax.

Property, Plant and Equipment

Office Furniture and Equipment

Office Furniture and Equipment are carried at cost or fair value less, where applicable, any accumulated depreciation and impairment losses. All assets are depreciated over the estimated useful lives of the assets to the entity.

Depreciation

The depreciable amount of Office Furniture and Equipment are depreciated on a written down value (WDV) basis over their useful lives to the entity commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each balance sheet date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are included in the income statement. When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained earnings.

Revaluation of (Short Term Accommodation House)

The Short Term Accommodation Home owned by Family Access Network Inc was revalued to its market valuation during the year ended 30th June 2021. This resulted in an Asset Revaluation of \$436,352 during the year.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30TH JUNE 2025

Loans and receivable

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are stated at amortised cost using the effective interest rate method. **Held-to-maturity investments**

These investments have fixed maturities, and it is the entity's intention to hold these investments to maturity. Any held-to-maturity investments held by the entity are stated at amortised cost using the effective interest rate method.

Available-for-sale financial assets

Available-for-sale financial assets include any financial assets not included in the above categories. Available-for-sale financial assets are reflected at fair value.

Financial liabilities

Non-derivative financial liabilities are recognised at amortised cost, comprising original debt less principal payments and amortisation.

Derivative instruments

Derivative instruments are measured at fair value. Gains and losses arising from changes in fair value are taken to the income statement unless they are designated as hedges.

Fair value

Fair value is determined based on current bid prices for all quoted investments. Valuation techniques are applied to determine the fair value for all unlisted securities, including recent arm's length transactions, reference to similar instruments and option pricing models.

Impairment

At each reporting date, the entity assesses whether there is objective evidence that a financial instrument has been impaired. In the case of available-for-sale financial instruments, a prolonged decline in the value of the instrument is considered to determine whether impairment has arisen. Impairment losses are recognised in the income statement.

As a not-for-profit entity the value in use of an asset may be equivalent to the depreciated replacement cost of that asset when the future economic benefits of the asset is not primarily dependent on the asset's ability to generate net cash inflows and where the entity would, if deprived of the asset, replace its remaining future economic benefits.

Provisions

Provisions are recognised when the entity has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

Employee Benefits

Provision is made for the entity's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits have been measured at the current value of the expected eventual payment.

Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short-term borrowings in current liabilities on the balance sheet.

Unspent Grant Funds / Contract Liabilities

Unspent Grant Funds now referred to as Contract Liabilities which available as revenue or liable to be returned to the grant provider in the following year are recognised as a current liability in the balance sheet. They are not treated as an operating surplus or profit.
